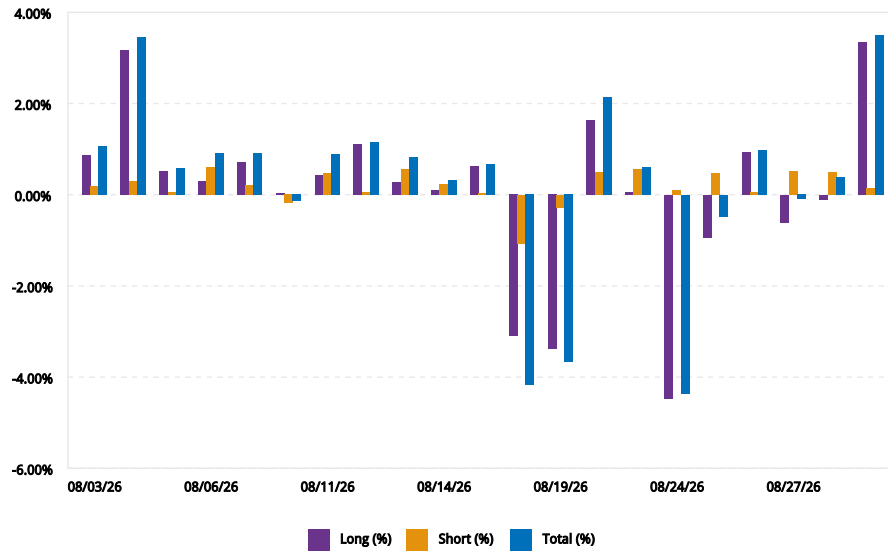
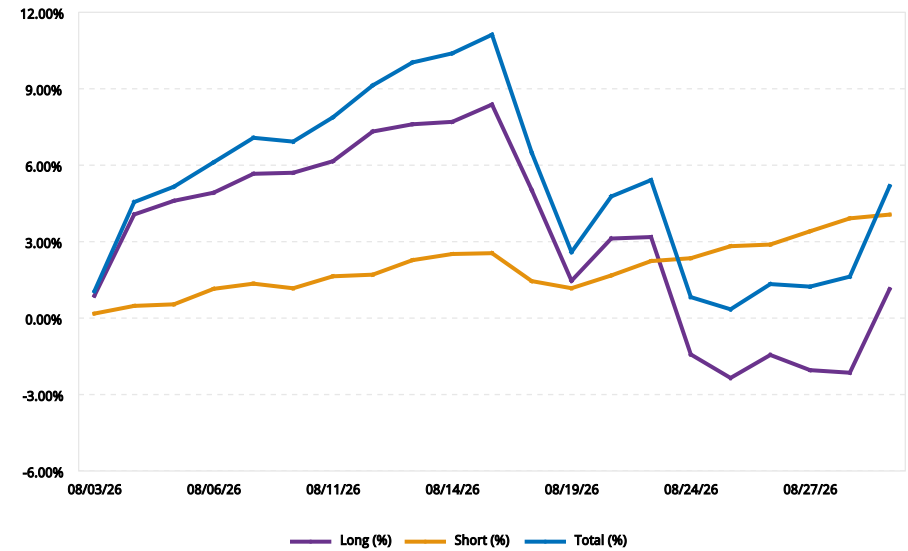

General Notes
